

Personal Data Protection Policy

We protect your data, you decide how we process them.

Personal Data Protection Legislation will change very soon and we will inform you on the details below, as well as remind you how we process your personal data in BBVA.

Who is the data controller of your personal data?

Banco Bilbao Vizcaya Argentaria, S.A. ("BBVA") with registered office at Plaza de San Nicolás, 4, 48005, Bilbao Spain.

Who is the BBVA Data Protection Officer and how can you get in touch with him?

The Data Protection Officer is the person in charge of protecting the fundamental right to personal data protection in BBVA and is responsible for compliance with data protection regulations. What do we use your personal data for?

At BBVA we process your personal data to manage the relationship we maintain with you, whether as a stakeholder because you have expressed your interest in receiving information and be updated.

If you are an investor, we inform you that the information subject to processing refer to you as a legal representative or contact person.

If you signed up to the subscription service available through the website, we process your data for the management and delivery of such communications, just as you have configured the service.

Why do we use your personal data?

The legal basis that allows us to process your personal data as a stakeholder and investor is the contractual relationship with BBVA (as owner of BBVA's shares) as well as the fulfillment of obligations imposed by laws and regulations, among them, the Royal Legislative Decree 1/2010, of July 2, which approves the revised text of the Capital Companies Act.

In the case of the subscription service, you gave your consent when registering in it.

How long will BBVA keep your data?

We will keep your personal information for as long as your status as a stakeholder and investor lasts. Once you are not a stakeholder of BBVA, we will keep your personal data blocked for 10 years by regulations for the prevention of money laundering and financing of terrorism. After the aforementioned deadline, we will destroy your data.

The data related to the subscription service will be kept until you communicate the cancellation of the service. Once unsubscribed, we will delete your data. You can unsubscribe at any time through your account <https://shareholdersandinvestors.bbva.com/login/>.

To whom will we communicate your data?

We will not pass on your personal data to third parties unless we are required to do so by law.

To be able to provide an adequate service and manage the relationship we maintain with you, certain companies that provide services to BBVA may have access to your personal data. In the

event that international data transfers are made, these shall be made to countries with a level of protection comparable to that of the European Union (Decisions issued by the European Commission, standard contractual clauses and certification mechanisms).
